- Currently, we are utilizing Costco, Dollar Tree, and the Central CA Food Bank to purchase and deliver food.
- Adjustments of buying has been made to accommodate our families in transition. Including, pop tops and pouch food.
- Quantity restrictions are now in place to control inventory. Exceptions are made depending on the situation.
