a) 2020-2021 Budget

2020-2021 budget proposal is presented. Goals are slightly adapted to reflect covid-19 and the everchanging global pandemic.

Income highlights include, Employee Contributions, Kaiser Grant and State of The District. Focusing on community driven events the foundation will slightly increase income goals for the following events, Janessa Ramirez Scholarship Event, Holiday Joy Food Drive, Coats for Kids and Winter Charge. Goals will be achieved by donations & sponsorships from the community and employees. Total projected Income \$142,432.00

Expense highlights include, Foundation Pillars: Agriculture, Arts, Academics and Athletics allowance to increase by +\$500 each. Increase in classroom grants by +\$4500 for a total of \$12,000 in grants. A 7th, \$2500 Janessa Ramirez Scholarship for a total of \$17,500 awarded in scholarships for the 2020-2021 school year.

New Teacher Grants will be changed to \$100 gift cards from Office Depot. Total budget \$4500.

Summer Library Program increased by +\$500. Note: Summer Reading Program will adapt if Covid-19 restrictions are still in place, ex. Virtual Reading Program. Total budget \$10k.

Coats for Kids will have an increased budget and number of coats for 2020 distribution. The event will also adapt due to covid-19. Total Budget allocated is \$20k.

A \$500 Visa Gift Card will be given away and a trinket will be given to all employees. Trinket options include a mask, keyless entry keychain and hand sanitizers.
